- iii) The GST registered certificate and that should be active.
- iv) The bidder should be enlisted in appropriate category from PSU/Government /Autonomous body, etc.

**6. The rate (excluding GST) is to be quoted in both figures and words.** Conditional quotations will not be accepted.

**7. All pages of the documents and credentials to be submitted by the bidder must be self-authenticated with signature and seal.**
