Corrigendum

This has reference to Tender No. Z-50/178/2021-AIIA (Tender id- 2022_AIIA_673961_1) for 'Empanelment of Pathology Centre/Laboratory for various Lab Services', the following addendum/ corrigendum are published here in for incorporation in tender documents.

1. Only NABL labs are allowed to participate in the bid.
2. Joint Ventures/Consortium are allowed to participate in the bid. However, the bidder will have to provide principal party details as a single contact source.
3. Workload of 3 months is given below in the annexure-I of this corrigendum. Accordingly, annual workload can be expected.
4. PBG will be 3% of tentative cost which will be derived on L1 rate of bid multiplied by expected workload of agreement period.
5. Bidders participating in the bid are allowed to MSME benefits as per Government policy. However, for the purpose of providing price to the MSME bidder if L1 is not MSME bidder then MSME bidders will be provided opportunity to meet the L1 rate of first 25% test of the entire list.
