- Candidates have to produce authentic Photo ID proof issued by Govt. organization, at the time of Interview along with a self-attested photocopy of the same.
- Before interview, candidates will be required to submit self-attested copies of all documents in support of their claim for eligibility along with originals for verification. Further, in case of any false or incomplete information found/observed with regard to actual eligibility in terms of approved Recruitment Rules, their candidature will be rejected summarily at any stage of recruitment.
- Candidates are advised to keep the following documents, that have to be produced during interview in front of the Selection Committee. Non-availability of the required documents may result in disqualification to appear before the selection committee:
 - Certificates in original in relation to qualification, experience, etc.
 - One set of self-attested documents.
 - One recent passport size photograph and photo id issued by the competent authority.
 - In the case of Govt employee, No Objection Certificate has to be submitted, if not applied through the proper channel.
 - Candidates belonging to SC/ST/OBC/EWS should have to produce a certificate in the prescribed form signed by the competent authority concerned.
 - Candidates belonging to OBC have to produce the latest caste certificate that he/she doesn't come under creamy layer issued by the concerned competent authority in the prescribed format.
 - Caste certificates will be verified by a screening committee and if the verification reveals that the claim is false, the services will be terminated forthwith without assigning any further reason.
