Back ground - A medical camp was conducted at Maheshwari Tewa Trust, Faridabad on 03/02/2019 by the directions of competent authority. Maheshwari Sewa Trust is a charitable trust organising various social service activities in Faridabad and surrounding areas since many years.

Camp activity - The team from AIIA, including 10 doctors and hospital employees gathered at the campus by 8:30am. The bus arranged by the organizers reached the campus by 8:30 am and all the medicines were loaded as per indent by the hospital staff.

By sharp 9:00am the AIIA team of doctors and staff started from the hospital and reached the camp site. All arrangements were done by the organizers, a reception area, pharmacy medicine distribution division, 7 OPD areas were allotted to the doctors. Breakfast was provided to the doctors and they started the OPD services by 10:00am.

Other than 2 general OPD, speciality services like ENT, Paediatrics (Kaumara), Panchakarma, Swastha vrutta was extended. By 11:00am a public meeting was organised for the official inauguration of the camp. Chief guest Shri. B.R. Maheshwari inaugurated the camp along with Dean AIIA, Dr. Mahesh Vyas and other senior faculty. Individually each doctors were welcomed and honoured by the organisers during the function.

The **public function** started with the address of Dr. Mahesh Vyas followed with presentations on topics and information of public interest by Dr. P. K Prajapathi, Dr. Rajagopala, Dr. Santosh, Dr. Vyasdev, Dr. Narayan, Dr. Prasanth, Dr. Divya, Dr. Alka . During the presentations each doctor other than the presenter attended the patients in various speciality OPD.

The patients had a free flow inside the camp, with very specific directions to each OPD from the reception area as directed by the AIIA staff. And also the patients had very free access to the free medicine distribution area.

Overall 429 patients totally registered for the camp

There were **263 male patients and 166 female patients.**

Among the patient's maximum number of patients had chief complaint of Joint Problems.
