- 3. The date for determining the age and qualification will be the closing date prescribed for receipt of application.
- 4. Reservation status will be applicable as per central government norms.
- 5. Institute reserves the right to make any amendment, cancellation and changes in this advertisement in whole or as per part without assigning any reason thereof.
- Any corrigendum/order regarding this advertisement will be issued on the website only. Candidates are advised to remain in touch with the website for this purpose. No separate corrigendum etc. will be published in Newspaper.

Applications not supported by the appropriate copy of claimed certificate for the reservation category (under Application Fee relaxation) shall be considered, as General/unreserved and fee amount will be paid accordingly.
