#### KSHARAKARMA TECHNICIAN COURSE

Ksharakarma is one kind of surgical procedure, where

Kshara (caustic / alkaline product obtained from the plant ashes) is applied in the form of Pratisaraniya or Ksharasutra. This procedure has obtained recognition from modern system of medicine for its efficacy in management for Fistula-in-ano and has been quoted in the standard text books of General

Ksharasutra Chiktsa

Ksharakarma technician Course has been designed and developed by Department of Shalya Tantra, AIIA, New Delhi to meet the acutely felt need of such skilled technicians in Ayurveda institutions and hospitals within and outside the country. It is a one-year course and will provide hands-on training in laboratory and operation theatres in addition to didactic



contents. The objective of the course is to equip and train the enrolled candidates to become competent technical help to Ayurveda Surgeons and anaesthetist. The Ksharakarma technician would organize the logistics for smooth running of the operation theatres. Additionally, he/she would prepare the surgical trolley, dressing table, instruments and Ksharakarma materials etc. The demand for skilled Ksharakarma technicians is on the rise as the Ayurveda Surgery is getting wide acceptance across the globe.

#### **Objectives of the Course:**

- To learn about the materials used in preparation of various types of Kshara & Ksharasutra, Kshara medicaments, standardization of Ksharasutra, sterilization, storage & packing.
- Cleaning & drying of proctoscopes, probes, preparation of surgical drum for sterilization etc.
- To understand SOP and protocols with respect to preoperative and postoperative care of Ksharakarma.
- To acquire the knowledge of process of sterilization of instruments and OT fumigation, collection of swab report for culture.

- To understand the basic function of IRC, Laser, electro-cautery, multipara Monitor Ksharakarma cabinet, succinate apparatus and other equipments available at AIIA.
- To understand the ethical responsibilities in patient care.
