4. The bid document should be under two bid system (i) Technical Bid and (ii) Financial Bid, i.e. technical bid and financial bid should be in two different envelop which be placed ina bigger envelop.

6. Amendments: Any amendments/corrigendum related to bid document, for any reason whether in its own initiative or in response to clarification requested by bidders, will be published on website of Institute and on CPPP only. Bidders should check these amendments regularly. AIIA shall not be responsible to notify such amendments/corrigendum to individual bidders.

7. All India Institute of Ayurveda (AIIA) reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document or to reject any or all Bids without assigning any reason. The decision of the Director, AIIA in this regard shall be final and bindingon all.

#### Chapter-II Instructions for Bidders

 Tender has been invited under two bid systems. Hence all instruction should be followed properly as mentioned in bid document.

2. All envelops should be super-scribed "Technical Bid for supply of allopathic medicines" as the case may be. Both the bids should be kept in a bigger envelop super-scribed with "financial Bid for supply of allopathic medicines".

3. All the annexure/declaration and tender documents should be signed by bidders. If these are signed by a representative, an authorization letter issued after tender publishing dated must be attached. Tender submitted in loose sheet/unsigned shall not be considered.

4. The pages of tender document to be submitted by bidder should be properly number and an index with proper page number should be attached with the tender document.

 Rates quoted in respect of tender should be typed only. Any cutting, overwriting shall not be considered.

 The bidder shall quote rates in Indian Rupees (INR). Rates quoted in other currency shall be treated as non- responsive and will be rejected.

 Only technically qualified bidders will be considered for financial evaluation. Financial bid opening date and time will be intimated to technically qualified bidders only.

 Technical compliance sheet must be attached along with catalogue where in the technical compliance/composition of drugs/medicines will be intimated properly.

 It is responsibility of bidders to ensure timely submission of bids as per given schedule and must be dropped in Tender Box. Bids received after due date will not considered.

 In event of the above-mentioned date being declared as holiday/closed day for the AIIA, the tender event will be postponed for the next working day.

11. Price Preference Policy and Exemption for submission of various eligibility criteria documents to the Bidder registered under Make in India Initiative:- The bidders who are registered under Make in India Initiative and producing their products under the "Make in India Policy of Government of India" shall be given price preference as per Govt of India applicable Rules and Guidelines on submission of relevant certificate for availing the price preference and exemption for submission of exempted documents against this bid along with their Pre-Qualification Bid Documents. If the certificate is not uploaded along with their offer, it will be treated as normal bidder. Producing certificate at later stage will not be considered.

 Bidders are advised to go through the Make In India initiative and Price Preference Policy before opting the same for availing benefit under this initiative.

13. It should be noted that this tender is subject to the provisions contained in Government of India, Ministry of Commerce & Industry, Department for Promotion of Industry and Internal Trade (Public Procurement Section) Order No.P-45021/2/2017-PP (BE-II) dated 04.06.2020 and all other relevant orders issued by the Government of India from time-to-time.

(a) - The 'Class-I local supplier / Class-II local supplier at the time of tender bidding or solicitation shall be required to indicate percentage of local content and provide selfverification that the item offered meets the local content requirement for Class-I local supplier/Class-II local supplier, as the case may be. They shall also give details of

location(s) at which the local value addition is made. Only class I local supplier/class II local supplier are eligible to participate in the bid.

- (b) In cases of procurement for a value in excess of Rs. 10.0Cr, the 'Class-I local supplier/ 'Class-II local supplier' shall be required to provide a certificate from the statutory auditor or cost auditor of the company in the case of companies) or from practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content
- (c) False declaration will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the GFR-2017 for which a bidder or its successors can be debarred for up to two (02) years as per Rule 151 (iii) of the GFR-2017 along with such other actions as may be permissible under law.

#### Chapter-III

#### General Terms and Conditions

- 1. Tenders should be quoted only by the OEM/actual manufacturer and/or their authorized distributors only. Bidder should submit a current authority letter in support of the same from the actual manufacturer concerned in the format given at "Annexure- III". The bidder is responsible for the supply of stores. If the Principal Manufacturer withdraws rights of distribution from the bidder during validity period of rate contract, Director, AIIA, DELHI has right to cancel the eligibility of the bidder and accept the candidature of new coming authorized distributor. Any authorization certificate issued in the past for participating in any specific tender shall not be considered as a valid authorization by OEM.
- Rate contract will be initially for a period two years which can be extended further for a period
  of two years(year on year basis), on mutual consent of parties and on existing rate, terms &
  conditions.
- Bidders shall have to submit the samples of all medicines with their test reports and composition reports.
- 4. Patent Rights: The supplier shall, at all times, indemnify and keep indemnified the purchaser, free of cost, against all claims which may arise in respect of goods & services to be provided by the supplier under the contract for infringement of any intellectual property rights or any other right protected by patent, registration of designs or trademarks. In the event of any such claim in respect of alleged breach of patent, registered designs, trademarks etc. being made against the purchaser, the purchaser shall notify the supplier of the same and the supplier shall, at his own expenses take care of the same for settlement without any liability to the purchaser.
- Bidders must have attached affidavit of self-certification regarding local content as prescribed by Department of Pharmaceuticals vide its order F. No. 31026/36/2016-MD dated18<sup>th</sup> May 2018.
- 6. Country of Origin
- i. Only class I and class II local suppliers are allow to participate in the bid. Class I local supplier must have minimum local content 50% or above and class II local supplier must have local content in the supplies more than 25% and less than 50%. All the bidders shall have to submit declaration to

this effect along with address where local content is being added.

- ii. Bidders may ensure the compliance and guidelines mentioned in Office Memorandum No. 6/18/2019-PPD dated 23<sup>rd</sup> July 2020 issued by Department of Expenditure, Ministry of Finance and a declaration as per above O.M. must be furnished.
- Terms of Delivery: Goods shall be delivered by the supplier in accordance with the terms of delivery and as per the delivery period specified in the schedule of requirement and Supply & Delivery Clause in General Terms and Conditions Section. Please note that the time shall be the essence of the contract.
- Instructions for transportation of domestic goods including goods already imported by the supplier under its own arrangement: The supplier will arrange transportation of the ordered goods as per its own procedure up to Consignee Site (i.e. AIIA, Village-Dhargal, Taluka-Pernem, North Goa, Goa-403513)

## ELIGIBILITY CRITERIA

- (a) Only Class-I local supplier and class-II local supplier shall be eligible for participation. Bids from supplier (MSE/Non MSE) as defined in Department of Pharmaceuticals under Ministry of Chemicals and Fertilizer order no F. No 31026/65/2020-MD dated 30/12/2020 shall be accepted. Bids from firms/vendors other than class-I and class-II local supplier (MSE/Non MSE) shall be summarily rejected.
- (b) Tenderer shall be a manufacturer of quoted product (or Authorized Distributor with authorization letter) and having valid own manufacturing license in the indicated pharmacopeia (in technical specification at Annexure IA and Certificate of Pharmaceutical Product (COPP) as recommended by WHO in any of the pharmacopeia IP/BP/USP. The manufacturing license & COPP should be valid on the date of tender opening Bid.
- (c) For all regulated products, the bidder should have at least two years of manufacturing and marketing experience of the items as a manufacturer for each regulated product quoted in the tender. However, this would not apply to regulated products which have been licensed by DCG (I) less than two years ago. DCG(I) is permission shall be required for all new regulated products to this effect.
- (d) Average Annual turnover for Tenders in the last three years i.e. 2020-21, 2021-22 and 2022-2023 shall not be less than the following: - (i) The bidders who are quoting for all the bid, their turn over should not be less than Rs. 25.0 (Average annual turnover for last three overs). (ii) The bidders who are quoting for minimum quantities (i.e. 20%), their turnover should not be less than Rs. 10.0 lakh (average annual turnover for last three financial years)
- (e) Department of Expenditure, Ministry of Finance, GOI vide OM No: F.1/20/2018/PPD dated 02/11/2021 has issued guidelines on debarment of firms from bidding. The bidders blacklisted by any firm/company/CMSS/State Govt./Central Govt./its drugs procuring agencies prior to issuance of DOE OM No: F.1/20/2018/PPD dated 02/11/2021 are eligible to bid if: - The blacklisting order has been revised post facto with clearly mentioning of category (I) of OM No F.1/20/2018/PPD dated 02/11/2021 and that the debarment limited is to the issuing ministry/department/organization only. Such vendors should clearly mention the status of backlisting in the undertaking to be submitted in compliance with clause 6.1(I) of tender document and attach revised blacklisting order.

For blacklisting orders issued after02/11/2021, the following shall be applicable: -

- If the blacklisting order is issued by DoE, the bid of blacklisted bidder shall be out rightly rejected.
- If the blacklisting order is issued by CPSUs, attached offices/autonomous bodies etc of MoHFW/Other Ministries/departments and MoHFW/Other Ministries/departments by written approval has delegated powers under Sr.no. (8) of OM dated 02/11/2021 to such organizations/bodies that the blacklisting is applicable only for the Procurement made by such organization/bodies, the bid of such blacklisted bidders shall be accepted for further evaluation.
- In absence of such delegation extended by MoHFW, the bid of the blacklisted bidder shall be rejected.
- (f) Tenders should quote at least for 20% of the tendered quantity of each items quoted and the tenders shall have an annual production capacity not less than one and half times the quantity quoted for each schedule.
- (g) Tenderer should have supplied 40% of the quoted quantity of same or similar items during the last two financial years. Bidder should submit Purchase order copies (issued in the last two financial year) and certificate duly issued by statutory auditor of the company on his letter head by certifying the quantities manufactured and marketed in trade, export, open market, sold to government institutions, private bodies etc. and the marketed quantities are not less than at least 40% of the quoted/similar item.
- (h) Signed and scanned valid copy of Firm/Company Registration/Incorporation Certificate.
- Signed and scanned copy of GST Registration and proof of latest quarter GST returns filed copies by the participating Bidder Company.
- (j) Signed and scanned copy of PAN Card in the name of firm/company.
- (k) The bidders registered under MSME will be exempted from the submission of 'Turnover' and previous experience document, as per Government's guidelines. Bidders claiming the exemption should have submit relevant documents along with their offer. Any claim at later stage will not be entertained.
- (I) Drugs Manufacturing License
- (m)GMP Certificate
- (n) Bidder should have FDA registration, Schedule H and Psychoactive Drug Registration.

#### (o) FORGERY/FRAUD BY BIDDERS/SUPPLIER:

Genuineness of the papers/documents/certificates/declaration submitted with bid is the responsibility of the bidder. Also, the bidder should take utmost care in submitting undertakings/self-declaration/certificates along with its bid. If at any stage it is found that the papers/documents/certificates/declaration/undertaking/self-certification submitted by the bidder are false/incorrect/suppressed/misrepresented the fact or are not in order, are forged, manipulated, fabricated or altered, the bid or purchase order issued to the bidder is liable to

be cancelled Deposit, debarring/blacklisting against the bidder will be taken. Purchaser may also initiate police/legal action and request concerned statutory authority for cancellation of license issued to supplier for tendered items.

- (a) If any fraud, short supply of goods is detected on part of the bidder at any stage, the bid or work order/Purchase order issued to the bidder is liable to be cancelled and further necessary action against the bidder including debarring/blacklisting will be taken.
- (b) In any of above two cases, the AIIA is at liberty to make alternative purchase of the tendered items from other approved suppliers or in the open market or from any other Tenderer who might have quoted higher rates, at the risk and cost of the supplier.

#### TERMINATION FOR DEFAULT:

- (a) The purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the supplier terminate this contract in whole or in part.
- a. If the supplier fails to deliver any or all the goods within the time(s) specified in the contract, or any extension the thereof granted by the purchaser.
- b. If the supplier fails to perform any other obligation(s) under the contract, and if the supplier, in either of the above circumstances, does not remedy his failure within a period of 15 days (or such longer period as the purchaser may authorize in writing) after receipt of the default notice from the purchaser.
- (b) In the event the purchaser terminates the contract on whole or in part, pursuant to above the purchaser may procure; upon such terms and in such manner, as it deems appropriate, tendered goods undelivered and the supplier shall be liable to the purchaser for any excess cost for such similar goods. However, the supplier shall continue performance of the contract to the extent not terminated.

#### TERMINATION FOR INSOLVENCY:

The purchaser may, at any time, terminate the contract by giving written notice to the supplier, without compensation to the supplier if the supplier becomes bankrupt or otherwise insolvent, as declared by the competent court provided that such, termination will not prejudice or affect any rightof action or remedy which has accrued or will accrue thereafter to the purchaser.

#### SET OFF:

Any sum of money due and payable to the supplier (including security deposit refundable to him) under this contract may be appropriated by the purchaser and set off the same against any claim of the purchaser for payment of a sum of money arising out of this contract or under any other contract made by the supplier with the Purchaser.

Purchaser reserves the right to debar/blacklist a bidder for a suitable period in case he fails to honor his bid/contract without enough grounds.

#### BID SUBMISSION:

- (a) Bidders are hereby cautioned that any attempt of cartel formation will be viewed seriously and may at the discretion of purchaser, lead to cancellation of tender. Purchaser in its discretion may decide to forfeit EMD of such bidders and black list or debar these bidders for suitable period besides taking other punitive measures. Decision of purchaser in this regard shall be final and binding.
- (b) (i) Different firms or companies having any common partner(s) or Director(s) or representative not permitted to quote for more than one tender offer. In case more than one offer is received from such bidders, than all such offers except with the lowest quote shall be rejected summarily.

(ii) In case more than one offer for any tendered item is received from the same bidder, then all such offers except with the lowest quote shall be rejected summarily.

#### NEAR RELATIVE CERTIFICATE:

The bidder should give a certificate that none of his/her near relative as defined below is working in AIIA where he is going to apply for the tender. In case of Proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the company excluding Govt. of India/Financial Institutions nominees and independent non-official part time directors appointed by Govt. of India or the Governor of the state. Authorized signatory of bid may also sign this bid on behalf of the entire directors/ partners/ proprietor. Due to any breach of conditions by the company or firm or any other person the tender will be cancelled and bid security will be forfeited at any stage whenever it is noticed and AIIA will not pay any damage to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation for quoted item in the concerned unit.

The near relatives for this purpose are defined as:

- (a) Members of a Hindu undivided family.
- (b) They are husband and wife.
- (c) The one is related to the other in the manner as father, mother, son(s) & son's wife (Daughter in law), daughter(s) and daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).

#### **TECHNICAL BID- "PACKET1"**

- (a) The tendered should furnish the Manufacturing License valid on tender opening for each items quoted been duly renewed up to date and the items quoted shall be clearly highlighted in the license. Original documents should be produced for verification when demanded. If the tendered drug is in Indian Pharmacopoeia (IP), then the manufacturing license must be submitted in IP only.
- (b) Duly notarized general power of Attorney (on non-judicial stamp paper of worth Rs. 50/or above) in favour of authorized signatory in case of partnership firm (to be signed by all partners)/ proprietorship firm or board resolution in case of a company to sign the bid and bind the bidder. The signature of authorized signatory should be duly attested. In case of proprietorship on its letter head, the proprietor of firm declares himself as proprietor with specimen signature.
- (c) Manufacturing and Market Standing Certificate/Market Standing Certificate issued by the Licensing Authority as a manufacturer for each item quoted for the last 2 years i.e. 2021-22 & 2022-23 for compliance of tender clauses.
- (d) A valid Certificate of Pharmaceutical Product (COPP) as recommended by WHO in any

pharmacopeia IP/BP/USP and a valid WHO-GMP.

- (e) Capacity certificate issued by the licensing authority.
- (f) Tenderer should have supplied 40% of quoted or similar item during the last 2 financial years (Copies of P.O's to be submitted along with Statutory Auditor certificate). Similar items are defined at 4(g).
  - Non-Conviction Certificate issued by the FDA/Drugs Controller of the State certifying that the firm/company has not been convicted and the products quoted have not been cancelled during last two years i.e. 2021-22 and 2022-23.
  - Annual turnover statement for 3 years i.e. 2020-21, 2021-22 and 2022-23 should be furnished in the format given in Annexure-V duly certified by the Chartered Accountant.
- (g) Long Term (Real Time) Stability Data of the quoted product in specified packing for at least for 3 batches, to support shelf life.
- (h) A Checklist (Annexure-VI) indicating the documents submitted with the tender document and their respective page numbers shall be enclosed with the tender document. The documents should be serially arranged.
- (i) Near Relative Certificate as per Annexure-VII.
- (j) Draft artwork is to be submitted in technical bid.
- (k) Tenderer should submit an undertaking that "I/We do hereby declare that our firm has not been blacklisted/banned/debarred/by AIIA/State Governments/Central Government/MOH&FW or any of the procurement agencies/Autonomous Bodies under the organizations stated above or the Firm/Company (as whole)has not been debarred as a whole by these organizations or any of its procurement agencies/Autonomous Bodies".

# EMD: The bidders are not required to submit the EMD. However they have to submitsigned declaration as per annexure-II

#### OTHER CONDITIONS:

· The details of the annual required quantity of items are shown in Annexure-I

(i) AIIA will have the right to increase or decrease up to 25% of the quantity of goods and/or services specified in the schedule of requirements without any change in the unit price or other terms and conditions at time of award of contract.

(ii) In exceptional situation where the requirements is of an emergent nature and/or its necessary to ensure continued supplies from the existing vendors, the purchaser reserves the right to place repeat order up to 50% of the quantity of the goods and/or services contained in the running tender/contract up to a period of twelve months.

(iii) The delivery of the additional quantity (as per ii above) shall be scheduled after the completion of the delivery of the original tendered quantity or on mutual consent between the supplier and AIIA.

- (i) The rates quoted and accepted will be binding on the Tenderer for the full contract period of two years and any increase in the price will not be entertained till the completion of this contract period.
- (ii) Any upward/downward revision (only during scheduled delivery period) in statutory taxes, levies will be allowed and benefit will pass on to supplier/purchaser.
- (iii) Any increase in taxes and other statutory duties/levies after the expiry of the delivery date shall be to the supplier's accounts. However, the benefit of any decrease in these taxes/duties shall be passed

on to the purchaser by the supplier.

(iv) The delivery of the additional quantity shall be scheduled after the completion of the delivery of the original tendered quantity.

 In accordance to the notification the participating Micro and Small Enterprises (MSEs) in a tender, quoting price within the band of L1+15% would be allowed to supply a portion of the requirement by bringing down their price to the L1 price, in a situation where L1 price is from someone other than an MSE. In exercising of the powers conferred in Section 11 of the Micro, Small and Medium Enterprises Development (MSMED) Act 2006, the Government has notified a new Public Procurement Policy for Micro & Small Enterprises effective from 9<sup>th</sup> November 2018. The policy mandates that 25% of procurement of annual requirement of goods and services by all Central Ministries/ Public Sector Undertakings will be from the Micro and Small Enterprises. Government has also earmarked a sub target of 4% procurement of goods & services out of 25% from MSEs owned by SC/ST entrepreneurs and 3% to micro and small enterprise owned by women.

 The Department of Pharmaceuticals under Ministry of Chemicals and Fertilizers has issued guidelines for implementation of the provisions of public procurement (Preference to Make in India) order (PPO) 2017 revision related to procurement of goods and services in Pharmaceuticals formulations vide order no F.No 31026/65/2020-MD dated 30/12/2020. The relevant provisions of DoP order dated 30/12/2021 and DPIIT order dated 16/09/2020 and all subsequent orders from time to time will apply in the instant case. Bidders are requested to submit a declaration indicating percentage of local content and complete address of site where local content being added.

#### METHODOLOGY FOR PLACING ORDERS:

For placing orders, the following procedures will be adopted:

- (i) After the price Bid opening, the lowest offer will be declared as the L1 tenderer against each medicines.f
- (ii) The Tenderer, who has been declared as Lowest Tenderer for certain item(s), shall within the tender issue of LOA (letter of acceptance) execute necessary Agreement for the supply of the allocated quantity of such items as specified in the Tender Document after depositing the required amount as Security Deposit and on execution of the agreement such Tenderer shall supply goods on receipt of Purchase Orders. The format of LOA, agreement, Purchase Order is attached at Annexure- IX, X,XI respectively.
- (iii) If two or more than two Tenderers are declared as lowest suppliers for the same items(s) (i.e. emerge L1), such Tenderers shall execute necessary agreement as specified in the Tender Document on depositing the required amount as Security Deposit and on execution of the agreement such Tenderer will be eligible for placement of purchase orders for equal proportion of tendered quantities (50:50 or 33.33:33.33:33.33) for such item(s) for which they are declared as lowest(L1).
- (iv) In case of MSME start-ups and class-1 local supplier AlIA will counter offer the lowest rate (L1 rate) to other Tenderers in the order of their ranking i.e. L2, L3 and so on will be asked to match the L1 price, if their bids found within the prescribed limit.
- (v) If the lowest supplier has failed to supply the required items within the stipulated time or within the extended time AIIA may cancel such purchase orders and on cancellation, AIIA may place Purchase Orders with the Matched Lowest Tenderer or to the other tenderers at the risk and cost of the defaulted supplier.

(vi) The supplier shall complete the supply of the items required by AIIA at the consignee destination mentioned in the schedule, within minimum required period as stipulated in order from the date of the orders.

(vii) The supplier shall supply the items at the specified destination and submit a copy of the Purchase Order, Delivery Challan and other relevant documents at the same destinations.

(viii) After supply of items at the specified destinations, the supplier shall submit Invoice (Original), Certificate of analysis (Batch wise) and other relevant documents etc., at the Head office, AIIA for claiming payment.

(ix) Subject to para(vii) and (viii) above, AIIA will process the invoices submitted by the supplier and the payments against supply will be made within 30 days from the date of submission of all relevant documents to the AIIA provided the items supplied has been declared of STANDARD QUALITY, by the empaneled Laboratory of AIIA.

#### SUPPLY/ DELIVERY CONDITIONS:

(i) The supplier should acknowledge the receipt of the Purchase Order within 3 days of its receipt.
 (ii) The supplies will be made in staggered quantities (if applicable) as detailed in Annexure-I

(iii) (a) The supplier shall be supplying the ordered quantity within period of 30 days (or as mentioned in LOA/PO) from the date of award at the destinations mentioned. If the above day happened to be a holiday for AIIA, the supply should be completed by 5.00 PM on the next working day. In case of non-execution of the order either partially or fully, AIIA reserves the right to cancel the purchase order or place fresh purchase orders on alter4native source at the risk and cost of the default supplier. In such cases the AIIA, has every right to recover the cost and impose penalty including blacklisting of the supplier and the product.

(b) With the prior approval of AIIA, the supplier may continue to supply the unexecuted quantity after 30<sup>th</sup> day or after the delivery dates/schedule as mentioned in order with Liquidated Damages provisions specified in tender document.

(c) Supplies should be made directly by the tenderer and not through any other Agency/Dealer/Distributor.

(d) The Tenderer shall not, at any time, assign, or make over the contract or the benefit there of or any part thereof to any person or persons whatsoever.

- (iv) All goods must be of fresh manufacturing and must bear the dates of manufacturing and expiry. The bidder further warrants that all goods supplied will have, at least half of the minimum shelf life must remain at the time of delivery to the consignee. The supplier will provide manufacturer's stability test data substantiating the claimed shelf life of the offered package.
- (v) The items delivered to AIIA, the supplier should ensure that the items are delivered with the minimum shelf-life as mentioned in the tender document/Purchase Order failing which the consignees/AIIA shall not accept the items. Further, the bidder's attention is invited that if they supply/deliver the items with short shelf-life as per tender/Purchase Order and even if direct consignees receive such items, the invoices shall not be processed by AIIA for payments. It is the sole responsibility of the bidder/vendor to deliver the items with minimum residual shelflife as mentioned in the tender/Purchase Order.

- c. Date of manufacture

- e. Manufacturer's name
- f. Number of samples tested
- g. Testing principles

Information about reference used

- h. TESTING PROCEDURE-Sensitivity, Specificity etc.
- i. Results
- j. Report number
- k. Date of Analysis
- Designation and signature of analyst
- m. Authorized signatory of lab

The above-mentioned batch shall be manufactured in accordance with the applicable GMP/QMS regulations.

- (vii) All the Tenderers ae required to supply the product(s) with printed text "AIIA SUPPLIES-NOT FOR SALE" in red-colour on the strips, blisters, vials, ampoules & bottles and on the external packings. The type/thickness of packing materials used in Blister packs may also be specified. Goods received without this print will not be accepted by AIIA/Consignees. Affixing of rubber stamp shall not be accepted. However, the approved art work will prevail.
- (viii) If at any time the Tenderer has, in the opinion of the AIIA, delayed the supply of items due to one or more reasons related to Force Majeure events such as riots, mutinies, wars, fire, storm, tempest or other the items may be extended by the AIIA at its discretion for such period as may be considered reasonable. However, such extension shall be considered only if a specific written request is made by the Tenderer within 10 days from the date of occurrence of such event. The exceptional events do not include scarcity of raw material, increase in the cost of raw material, electricity failure, labour disputes/strikes, insolvency, and closure of the factory/ manufacturing unit on any grounds etc.
- (ix) The supplier shall not be liable to pay LD/ penalty and forfeiture of security deposit for the delay in executing the contract because of the extension of supply period on the ground of force majeure events.

#### PACKING:

(i) The items shall be supplied in the package specified in the Technical Specifications in Annexure-I

(ii) The Weight, Volume & Dimensions of shipping cartons & intermediate packaging carton may be mentioned.

(iii) The packing shall be of a sturdy quality to provide adequate protection of the product for carriage to destination, adverse climatic and storage conditions and high humidity. Used cartons should never be used.

(iv) Products with specific temperature requirements will be packed and stored and delivered in appropriate conditions.

(v) Special attention of suppliers is invited to ensure the material is of good quality and is free from development of fungus/termites. In case fungus/termites develops within 15 days of delivery at specified locations, suppliers at their own cost would lift the entire batch from various locations and supply fresh replaced batches. For LD purposes the date of receipt of replaced batches would count. In addition, the expenses on pest control to be undertaken by AIIA would be borne by the tenderer.

#### QUALITY CONTROL:

(i) Quality Control is an essential part of the current procurement and it is the responsibility of the supplier to ensure quality assurance as per specifications/bid document.

(ii) The bidder/supplier understand that the tender item/items/are critical health goods and the quality parameters of supplied goods are to be specification/bid document/official compendium. Bidder/Supplier also appreciate that failure in quality check serious default as it may derail entire programme and can also risk the life of users of supplied health goods.

(iii) AIIA will embark on stringent quality checks to ensure that tendered goods meet required standards throughout specified shelf life. For this purpose, AIIA reserves the right to carry necessary inspections/tests at any of, or any combination of or/all of following stages:

(a) At Pre-Dispatch stage

Pre-dispatch inspection for passing the quality of the goods, would be done before direct shipment to the consignees from supplier Warehouses (in India).

(b) At delivery stage: inspection done once the goods reach at consignee location and before taking over supplied goods in inventory.

(c) Post Delivery Surveillance: The Drugs/goods shall have the active ingredients and all other parameters at the prescribed level as indicated in official compendium sort technical specifications throughout the shelf life period of the drugs/goods. Quality Monitoring Activities may also be organized by AIIA post-delivery.

(iv) AlIA may engage the service es of a quality Control Agent & Quality Control Testing Laboratories for the purpose of Inspection & Quality Control.

#### (v) INSPECTION METHODOLOGY:

Pre-Dispatch Inspection of the medicines may be carried out by AIIA on its discretion. After completion of manufacturing process, the supplier should offer goods for PDI inspection in writing to Quality Assurance department of AIIA at least 10 days before proposed inspection date. The samples of each batch will be collected and sent to designated laboratories (Government/Private Drugs Testing Laboratories) for testing as decided by the AIIA. Handling and testing charges will be borne by AIIA. After the dispatch clearance of Quality Assurance department of AIIA, the supplier will deliver the items to the consignee or AIIA warehouses as

per the delivers/dispatches goods without completing the QA inspection, sample testing, dispatch clearance etc., AIIA shall not be processing the payments of such goods and the supplier will be solemnly responsible for the supply of such goods. PDI is not mandatory it will be on discretion of AIIA authority.

Non-PDI (Post Delivery Inspection): The supplier will deliver/dispatch the manufactured items (as per the technical specifications) directly to AIIA warehouses. The samples will be collected from the warehouse of AIIA and sent to designate Quality Control Labs in respect of supplied good satiny point during specified shelf life as per decision of AIIA.

In case of failure of batches during or at any stage (indicated at (v)), the testing charges would be claimed for the defaulting vendor.

(vi) The supplies will be deemed to be completed only upon receipt of the quality certificates from the laboratories.

"Not of Standard Quality" or spurious or adulterated or misbranded, such batch/batches will be deemed to be rejected goods.

(vii) At any of Inspection/testing stage, samples which do not meet quality requirement/specifications shall render the relevant batches liable to be rejected. If the sample is declared to be "Not of Standard Quality" or spurious or adulterated or misbranded, such

batch/batches will be deemed to be rejected goods and the cost of entire batch paid will be recovered whether consumed fully/partially. Besides action may also be initiated for debarring/blacklisting against supplier for suitable period.

(viii) In the event of the samples of Drugs/goods supplied fails in quality tests or found to be not as per specification at any of testing stages (as mentioned in clause no (iii)), depending upon the type, nature and seriousness of failure, consequences resulting from such default, availability of alternate sources, the AIIA is at liberty to either:

 Ask the supplier to replace the entire quantity of relevant batches, in addition to imposition of penalty @ 25% of batch supply cost or

(ii) To make alternative purchase of the items of Drugs from other approved suppliers or in the open market or from any other Tenderer who might have quoted higher rates, at the risk and the cost of the supplier.

(iii) In addition to (i)or(ii) above, action to debar/blacklist the supplier for suitable period, as decided by AIIA may also be initiated. In addition to forfeiture of Performance Security Deposit.

(iv) In addition, the FDA/Drugs Control Authority of concerned Stage will be informed for initiating necessary action on the Tenderer in their state. Security deposit will also be forfeited without any intimation.

(v) The decision of the AIIA or any officer authorized by AIIA, as to the quality of the supplied drugs, medicines, vaccines etc., shall be final and binding.

(ix) In case of supply of "NOT OF STANDARD QUALITY" goods to AIIA the supplier shall make replace the rejected quantity by replacement within 2 months. If replaced batch is also found "NOT OF STANDARD QUALITY", the supplier shall be blacklisted for the product and no further supplies shall be accepted for the particular product category. In addition, the licensing authority will be informed for initiating necessary action on the supplier in their state. The security deposit will also be forfeited without any intimation. The warranty shall apply to replacement batches also. The decision of AIIA, as to the quality of the supplied goods shall be final and binding.

(x) If the product is non-Pharmacopoeia then the supplier must provide the in-house test method

along with the required reference standards if asked for. The Master Formula of the products shall be provided whenever asked for.

#### PAYMENT PROVISIONS:

(i) No advance payments towards costs of items will be made to the Tenderer.

(ii) The payment towards supply of items to AIIA will be made through NEFT /RTGS (Real Time Gross Settlement System)/Core Banking. The tenderer shall furnish the relevant details in original to make the payment through RTGS/Core Banking/NEFT. The payment will be in INR only.

(iii) All bills/Invoices should be raised in duplicate and the bills should be drawn in the name of, Director, All India Institute of Ayurveda, Delhi-110076 or in the mane of any other authority as may be designated.

(iv) Payments for supply will be made only after completion of supply of items ordered in the individual Purchase Order Provided quality reports are acceptable. The AIIA shall endeavor to make payment within 30 days in respect of items requiring non-sterility test from the date of submission of invoice or from the date of receipt of material, whichever is later along with all the relevant documents of tender.

- (f) Bidders are requested to submit their Original Invoice along with copies of Delivery challans and as per format given in the tender document Annexure duly signed & stamped with other necessary documents for smooth processing of payment

#### LQUIDATED DAMAGES AND OTHER PENALITIES:

(i)DELAYS IN SUPPLIER'S PERFORMANCE:

a) Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule specified by the purchaser in its LOA/purchase order. In case the supply is not completed in the stipulated delivery period, as indicated in the LOA/purchase order or in case of non-submission of Security Deposit within the stipulated time, purchaser reserves the right either to short-close/cancel this LOA/purchase order and/or recover liquidated damage charges. The cancellation/short-closing of the LOA/Purchase order shall be at the risk and responsibility of the supplier and purchaser reserves the right to purchase balance-unsupplied quantity at the risk and cost of the defaulting vendor. This purchase at the risk and cost of the defaulting vendor can be at the same L1 cost of the tender or at higher cost and can be met through other vendors available in the present tender/contract or through any vendor from the open market. Any additional cost towards this risk purchase will be entirely borne/adjusted from

running bills/demanded from the defaulting vendor.

- b) Repeated/habitual delays by the supplier in the performance of its delivery obligations shall render the supplier liable to any or all of the following sanctions; imposition of liquidated damages, forfeiture of its performance security, and/or termination of the contract for default and purchaser reserves the right to purchase balance-unsupplied quantity at the risk and cost of the defaulting vendor.
- c) If the suppliers are not completed in the extended delivery period, the purchase order may be short closed without any compensation to supplier and the performance security shall be fortified.
- d) Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.
- e) Purchaser reserves the right to debar/blacklist the supplier for a suitable period who habitually failed to supply the goods/services in time. The decision of purchaser will be final and binding. (ii)If the supply reaches the designated consignee places or AlIA Warehouse after scheduled delivery date mentioned in LOA/P.O, liquidated damages will be levied @ .5% per week to be applied proportionately on per day basis up to a maximum of 10% of P.O. Cost, irrespective of the fact that whether the AlIA has suffered any damage/loss or not, on account of delay in effecting supply. If the last scheduled delivery day happens to be a holiday the supply will be accepted on the next working day without any penalty.

(iii)If the supply is received in damaged condition it shall not be accepted. In case of damage in the packing only, the supply may be accepted subject to purchaser's decision and after levying a penalty which may be upto 5% of cost of package received with damaged packing.

(ivs)Timely supply is the essence of contract/ Purchase order. The drugs/medicines/items ordered are meant for key National programmes & delay in supply can have the adverse impact on patients can derail the critical National level Disease Control Programme.

For each lot/tranche, the delivery schedule (dates) are mentioned in the LOA/PO. The vendors are to make every effort to complete the delivery of each Lot/Tranche as per delivery schedule mentioned in the LOA/PO.

#### WARRANTY

I. The supplier shall warrant that goods/items to be supplied shall be fresh manufactured and free from all defects and faults in material, workmanship and manufacturing and shall be of the highest grade and consistent with the established and generally accepted standards for materials of the type ordered and shall perform in full conformity with meet the composition throughout specified shelf life. The supplier shall be responsible for any defects that may develop under proper storage/ use, arising because of improper quality of API, Excipients in packaging material etc. manufacturing/packaging details from faulty materials, manufacturing or workmanship or otherwise and shall remedy such defects at his own cost when called upon to do so by the purchaser who shall state in writing in what respect stores faulty.

#### DEDUCTION & OTHER PENALTIES ON ACCOUNT OF DELAYS/ DEFAULT

#### /TERMINATION/PART CANCELLATION/SHORT CLOSURE:

(i) The AIIA will be at liberty to terminate, without assigning any reasons thereof, the contract either wholly or in part or short closed on 30 days' notice. The Tenderer will not be entitled for any compensation what so ever in respect of such termination besides forfeiture of Security Deposit and purchaser reserves the right to purchase balance-unsupplied item at the risk and cost of the defaulting vendor.

(ii) For infringement of the stipulations of the contract, for non-performance/ compliance of contractual terms or for other justifiable reasons, the contract may be terminated either wholly, or in part or short closed. By the AIIA and the Tenderer shall be liable to pay for all losses sustained by the AIIA in consequence of the termination which may be recovered personally from the Tenderer or from his properties, as per rules besides forfeiture of Security Deposit.

(iii) In the event of making Alternative Purchase, penalty will be imposed on the supplier. The excess expenditure over and above contracted prices incurred by the AIIA, in making such purchases from any other sources or from the open market or from any other Tenderer who has quoted higher rates and other losses sustained and the process, shall be recovered from the Security Deposit or from any other money due and become due to the supplier and in the event of such amount being insufficient, the balance will be recovered personally from the supplier as per rules.

(iv) In all the above conditions, the decision of the AIIA shall be final and binding.

#### SAVING CLAUSE:

No suit, prosecution or any legal proceedings shall lie against the Tender Inviting Authority or any person, employee of AIIA for anything that is done in good faith or intended to be done in pursuance of the tender.

#### PROHIBITION OF INFLUENCING AIIA BY THE BIDDER:

No bidder shall contact or influence the AIIA or its employees on any matter relating to its bid from the time of bid opening to the time the contract is awarded.

Any effort by a bidder to influence the AIIA in the bide valuation, bid comparison or contract award decisions may result in rejection of the bidder's bid.

The bidder shall not make any attempt to establish unsolicited and unauthorized contact with the Tender Accepting Authority, Tender Inviting Authority or Tender Evaluation Committee after opening of the bids and prior to the notification of award and any attempt by any bidder to bring to be a extraneous pressures on the Tender Accepting Authority, Inviting authority or Tender Evaluation Committee, shall be sufficient reason to disqualify the bidder.

Not with standing anything contained in clause(iii) above the Tender Inviting Authority or the Tender Accepting Authority, may seek bonafide clarifications from bidders relating to the bids submitted by them during the evaluation of bids.

#### RESOULUTION OF DISPUTES:

The AIIA and the supplier shall make every effort or solve, amicably by direct informal negotiation any disagreement or dispute arising between the tender or in connection with the contract.

In case of a dispute or difference arising between the AIIA and a supplier relating to any matter arising out of or connected with his agreement, such dispute or difference shall be settled in accordance with the Arbitration and Conciliation Act, 1996. The venue to arbitration shall be New Delhi.

#### JURISDICTION:

In the event of any dispute arising out of the tender such dispute would subject of the jurisdiction of the Court within the city of New Delhi only.

Tender currencies: The Bidder supplying indigenous goods or already imported goods shall quote only in Indian Rupees (INR) in the Financial Bid Format given at Annexure-V. A Bidder quoting imported goods located within India shall produce documentary evidence of the goods having been imported and already located within India, in case their bid is found to be the lowest one after opening of financial bid.

#### Additional information and instruction on Duties and Taxes:

(a) Octroi Duty and Local Duties & Taxes: Normally, goods to be supplied to Government Departments against Government contracts are exempted from levy of town duty, Octroi duty, terminal tax and other levies of local bodies. Supplier Agency should have mandatorily to pass on the benefit due to reduction in rate of tax to the AIIA DELHI by way of commensurate reduction in their prices. If any Supplier Agency found defaulter for following of above said rule (i.e. passing all the benefits of GST Tax Regime price reductions to AIIA DELHI), the necessary action deemed fit as per GST Act 2017 shall be initiated against such defaulter firm.
