#### SNIFFIN'S STICKS TEST KIT- EXTENDED TEST

Purpose:- For a complete assessment of the olfactory function the complete extended Sniffin' Sticks test kit is used.

The extended test exists of the identification test (16 pens), discrimination test (48 pens) and threshold test (48 pens). All of the tests will be delivered complete with the manuals, holders and evaluation material.

Approx. Estimated Cost: Rs 2,18,300/- (Rupees Two lakh eighteen thousand three hundred only)

## SPECIFICATIONS - ODOFIN SNIFFIN' STICKS - EXTENDED TEST N-BUTANOL

This is the complete test including the identification, threshold and discrimination test plus the manuals and needed materials.

Should be felt-tip pens that are filled with a fragrance liquid instead of ink.

Should be reusable for an unlimited number of people before the expiry date.

Each stick should provide with a printed expiration date.

The odor of the target pen of n-butanol version should have an alcohol like smell.

The extended test should contain three modules: threshold test, discrimination test and identification test.

## 6. Should have following contents:

a) The threshold test should have 48 Sniffin' Sticks (32 blanks and 16 dilutions n-butanol). This

module could be used to ascertain the patient's olfactory threshold.

The discrimination test should consists of 48 Sniffin' Sticks (48 Sniffin' Sticks = 16 pairs of odorants each with 1 individual smell). In this case, the patient must differentiate between more or less similar smells.

The identification test (blue version) should consists of 16 Sniffin' Sticks with everyday smells which the patient has to name using a selection card containing four definitions each. The complete test should come with an instruction manual, evaluation material and holder.

#### 7. Optional Accessories:

- -Cotton Gloves
- -Sleeping Mask

#### 8. Shelf Life:

The shelf life for the Identification Test and Discrimination Test should be approx. 1.5 year.

The Threshold (n-butanol ) Test should be approx. 8-9 months
