




Sealed item rate quotations are invited for above said work.

2. Estimated Cost id Rs. 5,00,000.00 The work to be completed within **5 Days** from the date of written instructions to carry out work.
3. The contractor should be registered with GST. Proof of registrations should be attached with quotation.
4. Quotation submitted without the EMD & GST registration certificate shall be rejected, whether they may be lowest
5. . The all documents submitted shall be self attested with seal/stamp of firm/company.
6. All rates shall be quoted on the quotation form and shall include material, labour, transportation. all taxes & duties, supervision, tools, plants, wastage, sundries, scaffolding as required mobilization, demobilization, transportation etc. and nothing extra shall be payable on this account.


