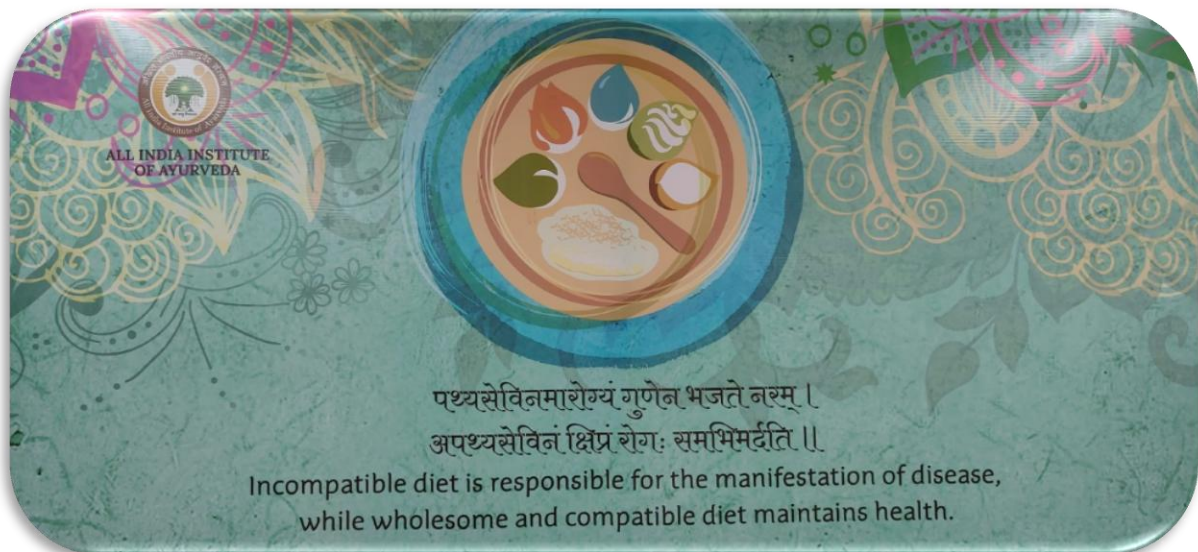

Eligibility for Admission : B.A.M.S. (Degree Completed Candidates Only)

Age Limit : 25 – 40 Years

Health Status : The candidate must be physically fit along with good physical and mental endurance.

Duration : 6 Months (Full Time - Physical Presence Mode Only)

Medium of Instruction : English and Hindi

Seats : 30 per Batch

Canteen Facility : Available on Monthly Payment basis.

Hostel Facility : Not Available (As per Availability Accommodation may be Provided to some candidates on First come First and Monthly Payment Basis)

Selection Procedure : Based on Merit or Counseling / Entrance Exam.

Provisional Selection : After the scrutiny, candidates will be informed about provisional selection by the institute email goa-office@aiia.gov.in or aiiaswastha@gmail.com

Admission Confirmation : After the confirmation reply to the provisional selection email by the candidates along with submission of soft and hard copy of Demand Draft (DD) of full fees Rs. 16,000/- within 7 days of provisional selection mail, the admission will be considered for confirmation.

Counseling and Medical Examination :

- Provisionally selected candidates have to appear at the institute for counseling on specified date and time at their own expenses.
- Candidates shall send a medical fitness certificate duly authorized by Registered Medical Partitioner.
- Candidate will be medically examined by a Medical Board of the institute, to certify their medical fitness.

Admission Confirmation Policy:

- ❖ The admission of the candidates will be confirmed and the course will commence only if minimum 5 Students have finalized the admission in a Batch or as per the directions of competent authority.
- ❖ The date of commencement of course will be communicated with the students after approval of the competent authority.

3. The date for determining the age and qualification will be the closing date prescribed for receipt of application.
