- No Objection Certificate:** If the candidate is working in a Government / Semi-Government / PSU Institution, a No Objection Certificate is mandatory.

under the OBC category must produce a valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013-Estt (Res-I) dated 31.03.2016. The certificate must be valid for employment in Central Government Institutions. OBC candidates' eligibility will be based on Castes borne in the Central List of the Govt. of India. Their Sub-caste should also match the entries in the Central List of OBC, failing which their candidature as an OBC candidate will not be considered. The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

- ii) *The vacancies advertised under the EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under the EWS category will be considered subject to the submission of an Income and Assets certificate in a prescribed format issued by the competent authority and subject to verification of the genuineness of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, the crucial date for submitting the income and asset certificate by the candidate is the closing date for receipt of the application for the post, except in cases where a date is fixed otherwise. Accordingly, an EWS certificate issued in the prescribed format for employment in the Central Government based on the income of the financial year 2022-2023, issued from 01.04.2023 but not later than 31.03.2024 and valid for the year 2023-2024, will be considered valid.*
