In pursuance to the 100 -day Campaign for TB elimination launched by Ministry of Health and Family Welfare on 07.12.2024, Ministry of Ayush, Government of India is going to launch a Training cum Awareness Program as "End Latent Tuberculosis" in the form of lecture series in pan India to make people aware about diagnosis and management of Latent Tuberculosis through Ayurveda. The campaign will be organized from 24.03.2025 to 24.04.2025.

The main objective of the campaign is to create awareness through lecture series to make Ayurvedic faculty/ Practitioners/ Students aware about the early diagnosis of the Latent Tuberculosis and mass awareness to the common people about the disease and the role of Ayurveda in its management. This campaign will assist to ensure the uniformity of information delivered to approximately 01crore target audience across India through 5 lakh lectures. This campaign will be immensely beneficial in understanding the disease in its primitive phase and encourage the vulnerable population to seek medical help at the earliest. This campaign will also help in increasing the active participation of Ayurvedic people in national health program and also strengthen the networking in all the health care sectors. This campaign will specially focus on the role of Preventive, Promotive and Curative management of Latent Tuberculosis through Ayurveda.

Campaign "End LTB with Ayurveda"

The expert groups from All India Institute of Ayurveda will provide standard presentation (Power Point Presentation) describing briefly the guidelines for diagnosis of the latent tuberculosis and management protocol, training and skilling the representatives of 28 states through online. The presentation will also describe dietary guidelines, Yoga and daily regimen for the latent tuberculosis patients. The PPT will be uploaded on the Ayush Ministry, AIIA, NCISM, CCRAS, RAV & State Ayush Directors, AIIA website for reference and will guide to organize lectures across India. Lectures can be organized across India to give wider publicity to the theme "Ayurveda for Latent Tuberculosis". Following Ayurveda fellows will actively participate by delivering 5 public lectures for awareness to the common public and screen 100 people for Latent tuberculosis -
