Train tickets must be booked from the Windows of Railways or from the IRCTC website.</li><li>3. <b>Please note that TATKAL or DYNAMIC PRICING train tickets will not be reimbursed.</b></li><li>4. On production of original bills, food bills not exceeding to Rs. 300/- will be paid for the journey period. No food expenses will be paid if the journey is made by Shatabdi/ Rajdhani/ Duranto trains.</li><li>5.
