2. If any document/Certificate furnished in a language other than Hindi or English, a transcript in Hindi/English of the same duly attested by a Gazetted Officer or Notary is to be submitted.
3. The date for determining the age and qualification will be the closing date prescribed for receipt of application.
4. Reservation status will be applicable as per central government norms.
5. Institute reserves the right to make any amendment, cancellation and changes in this advertisement in whole or as per part without assigning any reason thereof.
6. Any corrigendum/order regarding this advertisement will be issued on the website only. Candidates are advised to remain in touch with the website for this purpose. No separate corrigendum etc. will be published in Newspaper.

In case Institute observe any false or discrepancy in their certificate, their candidature will be rejected summarily. No correspondence will be entertained at all.
3. SC/ST/OBC candidates are required to produce original certificate in the prescribed copy of format signed by the specified authority, at the time of counseling. It is mandatory.
